WHEREAS, The Client is desirous of availing rental of a TravelScoot from The Service Provider.

NOW, THEREFOR in consideration of the mutual agreement and promises herein set forth, the parties hereto agree as follows:

1. One TravelScoot mobility scooter in full working condition free from any damage is made available to The Client for rent.
2. Payment of all monies as agreed upon made to the Service Provider before effective date.
3. The Service Provider will deliver or sent it by courier at the cost of The Client to the address of his preference.
4. The Client undertakes to maintain and care for the TravelScoot during period of rent.
5. The Client will not sub-rent or allow anyone else to use the rented item.
6. The client undertakes to deliver the TravelScoot, properly packed and in the same condition it was received.
7. The Client shall bear the entire risk of loss of and damage to the TravelScoot and accessories during rental period. In such case The Client shall immediately pay The Service Provider in cash an amount dictated by The Service Provider.
8. On termination of the rental period (30 days written notice on long term rentals) The Client undertakes to return to The Service Provider not later than 24:00 on the expiration date of the rental period at its own cost and expense to the address specified by The Service Provider.
9. The Service Provider undertakes to release holding deposit within 2 days of receiving it back.
